CERTIFICATE OF INCORPORATION

of the

APOSTOLIC EPISCOPAL CHURCH

Pursuant to Article II, Section 19 of the Religious Corporations Law.

Whereas, by the Act of the Legislature of the State of New York, known as Chapter 597 of the Laws of 1932, the existence of the Apostolic Episcopal Church is recognized, but necessarily as an unincorporated body, this being its status at the time of the passage of said amendment; and

Whereas, prior to April 1st, 1932, when said law took effect, this aforesaid unincorporated body functioned by virtue of an Agreement, made and entered into by and between two duly incorporated independent religious corporations not belonging to any denomination, said Agreement having been filed and recorded in the Registers Office, Queens County, New York, Liber #3437, page 355; and

Whereas, it has been determined that the said recognized unincorporated body, whose work and jurisdiction is to extend all over the United States, shall be continued as an incorporated religious corporation, from this time forth.

NOW THEREFORE, KNOWN ALL MEN BY THESE PRESENTS, THAT WE, the undersigned, all being persons of full age, and at least two-thirds being citizens of the United States, and at least one of us a resident of the State of New York, all of whom are members of two or more incorporated churches, namely: Christ's Church by-the-Sea and Lord's Evangelical Church, the duly incorporated churches that entered into

the Agreement herein before referred to, and several of whom are Officers of Metropolitan Synod, Apostolic Episcopal Church, acting in a representative synodical capacity referred to in Article III-A, section 54, Chapter 597 of the Laws of 1932; now desiring to form a general religious corporation of said Apostolic Episcopal Church for the purpose of organizing and maintaining mission churches and Sunday schools for said religious body, and of acquiring property therefor, pursuant to section 19 of the Religious Corporations Law,

DO HEREBY CERTIFY AS FOLLOWS:--

First: The name of the proposed corporation is to be APOSTOLIC EPISCOPAL CHURCH.

Second: Its principal office is to be located in the City of New York, Borough and County of Queens and State of New York.

Third: The number of trustees to manage its affairs shall be six, of which number three shall be the Bishop and Ecclesiastical Administrator, Vicar-General and Chancellor.

Fourth: The names of the trustees who are to serve for the first year of its existence are as follows:
